
Prayers of Concern for Jimmy Burnett's job issues; for Elaine Tucker's friend Tia; for Henri Smith's greatniece Kora

## Happy 148th Anniversary to First Christian Church

NOTE: Karen Kandik has been researching and writing about First Christian's history for several years. She shares this reflection on words by one of the church founders.



Words written in 1898 by A.T. Ankeny (picture above), one of the founders of our church, as he reflected on our church's beginnings on February 14, 1877:

What was the purpose? Was it to merely establish another Church of another name or denomination? Nothing could be further from their (the founders') thoughts. Was it to merely get what is called "a church home"? There were a score or more of such which offered more comforts. It was a deep and abiding conviction that a church should be here established after the original pattern set by the apostles and hearing only the name of the Master and governed only by His laws. A church which deplored invitations or strife and sought only the fruits of peace. There was no thought of saving the individual soul, for that would take care of itself by an upright life and an unswerving faith. It was a determination to reconcile the absolute sovereignty of God and His revelation by His Son, and that revelation to be the law for the church. It was to be emphatically "a pillar and support of the truth", and as such would bless to the utmost all who should come within its reach.

Has it attained success? Measured by everything good it has. No man can estimate its influences in the past 20 years in this city and state. No man in the future can cast the horoscope of what it may still achieve.

I would invite you to reflect on this original mission of the formation of what has become First Christian. How have we fulfilled this original mission and what have we consciously left behind? Some things to consider: "seeking the fruits of peace"—our mission and outreach work. "A pillar and support of the truth"—our work to call out injustice and work to correct it. "Absolute sovereignty of God and His revelation by His Son"—at the heart of our faith, looking to Jesus for examples and guidance about how to live our lives.

I think our founders would be proud –and maybe even amazed!—at how their hopes for the church have blossomed and changed over the years. We face many issues today that they could never envision, yet we have adapted through the years and carry on their dreams today.

# First Christian Board Notes

Twenty-one FCC board members attended the January 21 meeting of the General Board. (Both pastors were in Iowa attending the Ministers Institute.) Items discussed included the following:

- Martha Harris proposed revisions on three of the 1997 Bylaws. The board approved motions eliminating the office of Superintendent and changing the name of the Stewardship Committee to the Finance Committee. Board tabled changes to office of Clerk.
- Soo-Kyung Rennert, new chairperson for Pastor Dan's PRC, presented a proposal for a Lilly Grant application for a sabbatical for Dan in the fall of 2026. After a lengthy discussion Pat Dunlop made a motion to support the development of a Lilly grant, acknowledging a tight deadline for completing the application, and endorsing the PRC in their commitment to this grant application. The board voted 18-0 in favor of the motion.
- Mike Cackoski reviewed the numbers on the December Year End budget report. We ended 2024 in the black, with a \$925 balance, thanks to additional income from our regular interest payments, the Look to the Future drawdown, the Trustee underwrite of insurance and a Wholeness Grant supporting the pastor's Creative Ministries.

### SpringHouse Treasurer needed

SpringHouse urgently needs a new treasurer! Without a treasurer, we cannot function as a three-church financial entity. Andy Rennert cannot continue to act in the treasurer role, as he is serving as treasurer for First and best practices preclude him from also acting as SpringHouse treasurer (for example, he can't be a signer for both First and SpringHouse). The SpringHouse treasurer is one of very few people who can act as a signatory for SpringHouse, meaning that without a treasurer, we do not have anyone managing our money market account or CDs. Moreover, there is currently no one acting as a liaison between the Finance Committee and the board.

Here are the SH Treasurer main responsibilities:

- Signer on SpringHouse checks and approver for SpringHouse credit card statements, etc. (i.e. needs to come to the church building somewhat regularly - just on Sundays is finein order to get and sign documents from the mail area)
- Member of the SpringHouse board and liaison between the board and Finance Committee
- Creates the SpringHouse budget. This is pretty much plug and chug by now. There's a spreadsheet. Mike C supplies most of the numbers.
- Leads the Finance Committee meetings. Zero prep needed here. We email agenda items prior to the meeting and then just go through them.

SpringHouse Finance is a relatively low-effort church committee. We rarely have homework other than reviewing the financial statements. The primary challenge with the treasurer position is the need for that person to serve on both the Finance Committee and the SpringHouse board. We may need to revisit that requirement in the charter if we cannot find someone to serve as treasurer.

We appreciate you taking this issue seriously. Please reach out to Martha Harris, FCC's SpringHouse Co-Chair, if we can assist with the process.

- 2024 brought a gradual but steady increase in building use by outside groups
- The Wedge Neighborhood food share now distributes three days each month, and rents out space in the lower level for food storage. They have signed on to a full year contract for 2025!
- Our kitchen tenant Brooke is still our most consistent tenant and our biggest source of rental income.
- Eight different theater and dance groups rented rehearsal space from us this year. Many of the have reported they love using our space, and it seems they're spreading awareness in their communities by word of mouth!
